



How to deposit funds



You can begin investing by depositing funds directly into your On Call account.

Every investor has a specific **On Call** account number.

To find yours, and any other entity you have, navigate to the **My Investment** section.

You can do this by clicking the **View My Current Investments** tile.

Or by clicking **My Investments** in the navigation bar along the top of the portal page.





Select the **On Call** section and your On Call account number will be listed on the left.

When there are funds available to invest, there will be an amount showing in the **Balance** column.





When transferring funds with your bank provider.

Use this **On Call account number** as a reference, along with your name, when depositing funds into our trust account.

You can find our trust account number by clicking the **Contact the Investment Team** tile.

Or by clicking **Contact Us** in the navigation bar along the top of the portal page.

Here you will find our:

- Trust account name
- Account number

All funds are to be deposited into our trust account with your:

- Account name
- On Call account number as the reference







You can also find these details when you are at the **Request Investment** stage after you have reviewed and selected an investment.

Enter your desired amount on the chosen investment, confirm the On Call account to be used with the dropdown arrow, then select the blue **Request Investment** button in the bottom right hand corner.





A pop out window with additional information, including next steps, will open.

Until the deposit clears, a note will be added to your Portfolio section reminding you the amount of funds required to complete your **pending** investment transactions.







If you need to find our bank details again, navigate to the **My Investments** section.

You can do this by clicking the **View My Current Investments** tile.

Or by clicking **My Investments** in the navigation bar along the top of the portal page.





Under the **Pending** tab in the My Investments section:

Find the pending investment you made and click on the blue and white **Details** button.

Here you will see further information about the pending investment.

Next to **Additional Fund Required** you will see instructions to deposit funds including:

- Payee name
- Reference requirements
